1. Do you store digital data in your jurisdiction?

2. How is it stored and for how long?

IT IS STORED IN THE COURT ACCORDINGLY TO THE STATUTE OF LIMITATIN PERIODS (GENERALLY 10 YEARS BUT FOR PERIODIC OR FINANCIAL CLAIMS 3 YEARS)

3. Who has access to the digital data in your jurisdiction?

DIGITAL DATA CAN BE ACCESED BY PARTIES. THEY MAY BE ACCESED ALSO BY NON-PARTIES E.G. JURNALISTS BY A CLEARANCE ISSUED BY A PRESIDENT OF THE COURT OR APPOINTED JUDGE.

4. Are there digital data protection rules in place in your jurisdiction?

YES, THERE ARE. THEY ARE GENERAL JUDICIAL DATA PROTECTION MEASURES PROVIDED BY LAW.

5. Who covers the costs relating to the storage and protection of the digital data in your jurisdiction?

IT IS COVERED BY THE STATE.
