KOOM GUS	WORKSHOP 1: How best to ensure work-life balance in the judiciary?
	The CEPEJ has begun exploring work-life balance in the judiciary to develop a potential tool. Justice professionals face high workloads and stress, likely affecting their well-being and commitment to their mission. Balancing successfully work, family commitments and personal life remains challenging for justice professionals who face specific challenges that judicial authorities should address. Enhancing work-life balance has also become increasingly important in enhancing the attractiveness of judicial professions. The workshop aims to collect practices that would help develop the tool in question tailored to the judiciary.

	The CEPEJ-GT-CYBERJUST is currently developing a « Technology » curriculum that should serve the member States in developing their legal education and training policies to ensure a successful transformation towards digitalised justice. Judicial services are increasingly delivered electronically, and AI tools are progressively deployed transforming procedures and working methods in courts, requiring a profound understanding of their functioning to ensure their safe and appropriate use in a judicial context. The pilot courts are invited to voice their individual needs and share existing measures.

	Despite continuous effort to implement legislation, policies and practices to promote access to justice, users frequently comment that justice remains inaccessible to some due to cost, complexity, lack of information, and professional advice and support and remote facilities. The CEPEJ-GT-QUAL is currently developing a Checklist for promoting access to justice to help policy makers and justice authorities to reflect on the extent to which they have taken all the steps necessary to ensure access to justice for all. The pilot courts are invited to share practices and underline areas needing improvement for broader access to justice.
